## For engagement of Expert for establishment of new services

### I. Background

National Federation of Farmers represents the largest network of farmers and farmer's organizations in the country. It has inherited all the institutional memory and experience from the Federation of Farmers of RM. It unites the effort of 43 local farmers' organizations and cooperatives, representing the voice of more than 3.000 members and cooperating with almost all key players in the agriculture and agribusiness sector.

National Farmers Federation has expanded its scope of action. This means that besides farmers, agricultural associations, and agricultural cooperatives, the organization will continue to strengthen and support vulnerable categories in rural areas, greater support for young people and women, and their direct involvement in the development of agriculture through decision-making and active action.

In addition to agriculture, one of the organization's main focuses is rural development, ie dealing with the problems and challenges that the rural population faces, such as poverty and limited approaches of the rural population to health services, education, information law, and decision-making power.

The main pillar of action is lobbying to define the problems from the field and by joint work and analysis will be presented in front of the competent institutions for finding a common solution, which is in the interest of the farmers and the welfare of our entire country.

The focus of the National Farmers' Organization, which will continue to function under the slogan "Together for success" and the logo that symbolizes the labour and production of our farmers, is solving the biggest problems, which is placement and quality production. The mission of the rebranded organization is the ORGANIZED FARMER LEADER IN THE AGRICULTURAL AND RURAL DEVELOPMENT OF THE

REPUBLIC OF MACEDONIA. The vision to which we strive is - PROFITABLE AGRICULTURE - STABLE VILLAGE.

From May 2021, NFF implements the project "Supporting small scale farmer in Republic in North Macedonia-Core support to NFF" that is supported by Swedish development organization We Effect.

The objective of the "Supporting small scale farmer in Republic in North Macedonia-Core support to NFF" is support of the implementation of the National Federation of farmers' Strategic plan, that aims at:

- Organizational development
- Establishment of a system for lobbying and advocacy
- Information and education of members
- Economic empowerment of farmers in rural areas (special focus on women and youth)



- Development of rural areas and adaptation of agriculture to the new climate change
- Improvement of gender equality
- Regional networking and cooperation with other agricultural associations and international organizations and institutions

# II. Objective of the assignment

The overall objective is to design and propose a comprehensive package of services for NFF members, targeting the needs of small-scale farmers and their associations in the areas of: Lobby and Advocacy, Education and training, Access to information, Production planning and standards, Market preparedness and linkage (particularly to domestic markets).

# III. Scope of work

The selected expert will be responsible for the following tasks:

- 1. Assessment of Current Services and Needs
  - Conduct a review of existing NFF member services and capacities.
- Consult with member associations, small-scale farmers, and NFF staff to identify key gaps and needs.
- 2. Mapping of Market Requirements
- Identify trends and demands in emerging and domestic agricultural markets.
- Assess required production standards, certification, logistics, and marketing needs for farmers to access such markets.
- 3. Design of Service Portfolio
- Propose a structured and scalable package of services tailored to small-scale farmers and their organizations.
  - Services should include, but are not limited to:
  - Advisory services and trainings (technical, financial, organizational)
  - Information dissemination systems (digital tools, newsletters, etc.)
  - Production planning support
  - Market readiness assessments
  - Linkages with buyers, processors, and aggregators
- 4. Implementation Roadmap
  - Provide a practical roadmap and timeline for piloting and rolling out the proposed services.
  - Suggest modalities for implementation: in-house, outsourced, or partnership-based.
- 5. Sustainability and Financing Model
- Recommend models for financial sustainability (e.g. fee-based services, donor support, cooperative mechanisms).

#### IX. Evaluation of the offers

Offers with incomplete documentation and/or offers received after the deadline will not be taken into consideration.

Best value for money principle will be taken into account by using a weighted scoring method to evaluate the combination of the applicants' qualification and experience (60points) and financial offer (40points).

The evaluation will allocate a total of maximum **100 points**, with maximum **60 points** for the service provider/expert's technical qualifications and experience and maximum **40 points** for the financial offer.

Service providers/expert must score at least 36 points in the technical evaluation (60% of the maximum available) to qualify for financial evaluation.

# X. Terms of payment

# XI. Declaration of relationships

The expert shall describe if he/she have any present or past business or personal relationships with closely associated party from NFF, its governing and executive bodies. Business relationships do not refer solely to contracting arrangements but also to one-off engagements. Personal relationships do not refer solely to immediate family, but also to extended relatives, friends, and acquaintances.

The purpose of the Declaration is to disclose such information which makes the offer and evaluation process more transparent and supports the bids in its relevance according to conditions on the open market.

Declaring any relationship shall NOT disqualify the expert from the procurement but rather contribute to more transparent evaluation process.
